- 1. Copies of all University Degrees / Diplomas
- 2. CV in English
- 3. Certified copy of the English language certification verifying (at least) a very good command of the language: level C1, as recognized by ASEP and as determined amongst others by a TOEIC, IELTS, TOEFL score or Advanced (CAE)
- 4. One recent passport size photograph
- 5. Personal statement of approximately 500 words, in English
- 6. Two confidential recommendation letters either in sealed envelopes or uploaded directly via the online application platform from the referee (for the FT program only academic references, for the PT program one reference can be professional)
- 7. Proof of employment record, if any required for part time applicants
